**AGREED ORDER ON PLAINTIFF'S MOTION TO COMPEL PRODUCTION
OF DOCUMENTS AND ANSWERS TO INTERROGATORIES**

THIS MATTER came before the Court on Tuesday, January 29, 2013 upon Plaintiff's Motion to Compel Production of Documents and Answers to Interrogatories from Defendants H.K. Hotel Management, LLC ("H.K. Hotel") and Tropic Ranch, Inc. ("Tropic Ranch") (the "Motion"). The Court is advised that the parties agree to the entry of this Order and is otherwise fully advised in the premises.

Accordingly, it is **ORDERED AND ADJUDGED** that the Motion is GRANTED. Defendants H.K. Hotel and Tropic Ranch shall respond to the following four discovery requests by Friday, February 8, 2013: (i) Plaintiff's First Request for Production to H.K. Hotel; (ii) Plaintiff's First Set of Interrogatories to H.K. Hotel; (iii) Plaintiff's First Request for Production

to Tropic Ranch; and (iv) Plaintiff's First Set of Interrogatories to Tropic Ranch. This Order may be enforceable with sanctions if H.K. Hotel and Tropic Ranch fail to comply its terms.
