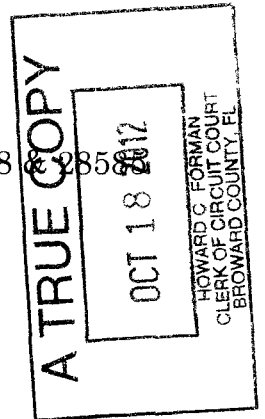


**PLAINTIFF'S CERTIFICATION OF AUTHORITY FOR MEDIATION**


