**DEFENDANTS' MOTION TO COMPEL MEDIATION**

Defendants, OCEAN 4660, LLC, HANNA KARCHO-POLSELLI and REMO POLSELLI, by and through their undersigned attorneys and Pursuant to Fla.R.Civ.P. Rule 1.710, hereby file their Motion to Compel Mediation and state:

1. Plaintiff, COMERICA BANK, filed the instant lawsuit to foreclose commercial real property and personal property, enforce loan documents, and for damages.
2. The lawsuit, filed on November 17, 2011, has been pending for almost a year.
3. On May 10, 2012, COMERICA BANK filed a "companion" case with regard to a neighboring parcel, under Case Number CACE12013597 (18), which involves the same parties in interest, and the same counsel.
4. In both cases, Defendant believes in good faith that, through a global mediation process, a settlement can be reached with regard to all of the pending issues between the parties.
5. At this juncture, making a concerted effort toward settlement before further litigation ensues, could avoid an unnecessary expenditure of fees, costs, and Court time, and could be of benefit to the litigants.
6. Pursuant to Fla.R.Civ.P. Rule 1.710, a civil action may be ordered to mediation upon motion of any party or by the court, if the court determines the action to be of such a nature that mediation could be of benefit to the litigants or the court.

7. No party will be prejudiced by the relief requested in the instant motion, and the equities favor such relief.

8. Defendants are filing a corresponding Motion to Compel Mediation in Case Number CACE12013597 (18).

WHEREFORE, Defendants, OCEAN 4660, LLC, HANNA KARCHO-POLSELLI and REMO POLSELLI, respectfully request the entry of an Order referring this case to Court-Ordered mediation within thirty (30) days, and awarding any other relief deemed just and proper under the circumstances.


